Bellingham Park HOA Pool Rules

- 1. Hours of operation are from 8:00 am to 10:00pm and are subject to change without notice.
- 2. Each homeowner must sign a waiver and release of liability prior to being authorized to use the pool.
- 3. There is no lifeguard on duty. All persons using the pool do so at their own risk. Bellingham Park Homeowners Association is not responsible for any accidents or injuries.
- 4. Swimmers must wear appropriate swim attire. Street clothes and shoes are not allowed in the water.
- 5. No diving, running, shoving, pushing, will be tolerated in or around the pool area.
- 6. Spitting, spouting water, or nose blowing is prohibited in the pool.
- 7. Any person(s) not potty trained must wear a snug fitting swim approved diaper.
- 8. Pets are not allowed in the pool enclosure except for service animals.
- 9. Alcoholic beverages are prohibited in and around the pool area.
- 10. Smoking is prohibited in the pool area (including e-cigarettes).
- 11. No glass is allowed in the pool area.
- 12. Loud music, shouting, screaming, or profanity is not allowed in the pool area.
- 13. No skateboards, roller blades, scooters, or bikes are permitted within the pool area.
- 14. All trash must be placed in the trash receptacles upon your departure.
- 15. The pool gate may not be propped open at any time! The pool gate must be closed and locked after entering. Violators will have their pool privileges revoked indefinitely.
- 16. Any damage to the pool, equipment, or fixtures will be paid for by the responsible party.
- 17. Homeowners with an outstanding balance or compliance issue will not have pool access until they are considered to be in good standing.
- 18. Food and drink are prohibited in the pool water.
- 19. Swimmers must shower before entering pool.
- 20. Each homeowner will be issued one (1) pool key. Replacement pool keys are \$75.00. Pool keys may not be copied or duplicated.
- 21. Parties, functions, events, meetings, or swimming lessons which are for the profit of an individual, business, or organization will not be allowed.

By the execution of this agreement, I accept and assume full responsibility for any and all injuries, damages, and losses of any time, which may occur to me and/or my guest, and I hereby fully and forever release and discharge the Bellingham Park Homeowner's Association its insurers, employees, officers, directors, and associates, from any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated, or unanticipated, resulting from or arising out of the use of said pool facilities.

I agree to indemnify, release, and hold harmless the Bellingham Park Homeowner's Association from any cost, liability, claim, damages, demand arising from injury, loss, illness, or death to me, or my guests caused by or related to the use of the swimming pool and its facilities.

I recognize and fully understand and acknowledge the information above. By signing this form, I expressly declare that I am of legal age and that I am aware of the full contents of this release, and I am legally accountable to any effects of this release.

Signature of a parent/guardian is required for persons under the age of 18.

I hereby consent my child and/or child under my guardianship to the use of the pool as described above. I acknowledge that I have carefully read this waiver and release of liability and understand all rules and conditions. On behalf of myself and my child and/or child under my guardianship, I expressly agree to indemnify and hold the company harmless against any and all claims, demands, damages, rights of action, or cause of action, of any person or entity, that may arise from injuries, damages, or wrongful death sustained by myself, my child or child under my guardianship. All rules and conditions above apply to my child and/or any child under my guardianship.
